

Acting on information gathered by Sgt. Brown, the garbage was gathered from in front of 422  
Bonnieview, to see if there may be any evidence from a couple of Agg. Burglaries in that area.  
The only things found in trash that were out of the ordinary were a couple of pictures of a  
w/f in fortys, and a military ID of Chester Charlton. Further investigation showed that Cha  
had reported a theft from his vehicle on 4/3/90. I contacted Charlton, he responded and stated  
that the ID was his and that the pictures were those of his wife, and they were in his wall.  
Nothing else of Charltons was found, and there is not enough evidence to charge anyone with  
theft, since there were five suspects living in the house at this time. However we are certain  
that these are the persons responsible for this theft and most likely many other thefts in  
area.
