Narrative:

On February 24, 1993 at 2:50 p.m.an interview with Joey Dalesandro and Investigator Craig. Interview done at Portage County Court House, Domestic Relations Court office. Joey's attorney Mark Heisa was present and Correction Officer Scott was present.

Joey stated the following:

Tyrone stated they got two rings and money from the Martig's house. Amount of money unknown. Told Gary to sell the rings. Doesn't know where rings went.

When Gary and Tyrone left car Gary had shot gun under shirttype thing and Tyrone had pistol (gun) in waistband. The shotgun was a single barrel with a home made sling made by Tyrone. The gun described as small and in good shape, all same color, black, the best he could recall.

When Gary and Tyrone came back to car, Tyrone put gun in glovebox. It stayed there until 4-9-90, when Joey got released from Alliance P.D., Joey cleaned his car, took gun to basement of parents house, where he was staying and hid the gun in a box. Some 4,5,6 days later they got call from Tyrone, telling him to get rid of gun. Joey took gun to Chico, sold it to him for \$20.00.

Also when Tyrone and Gary got back in car. Tyrone said to hurry back to Johnny's house so they could get rid of the evidence. Also, both Gary and Tyrone sweating when got back to car. They had grass on their Nike shoes. In car on way back, Gary tells Tyrone he shouldn't have done it. Gary says to Tyrone why did you kill them and Tyrone said he didn't want no witnesses.

At Trandafir's house, Tyrone said to Joey "if you say anything I'll kill you. Joey also saw Tyrone put gun to Butch's head and heard Tyrone say to Butch if he told anybody or if he said anything he would kill him. He also threw Butch on the couch.

Gary said Tyrone was shooting like crazy. This was back at Trandafir's house. Joey said he thought the crime happened around 4:00 p.m., full day light but was getting late.

Upon return to the house, 421 Bonnieview, articles such as

purse, brown purse and other items unknown were put in bag or bags and taken to brook or a river pond and thrown away. Site of event is obtainable through Trandafir's back yard. Gary is the one who carried the purse. Joey does not know which robbery the purse came out of
