NOTES FROM INTERVIEW WITH JOE DALESANDRO AT THE LIMA CORR. INSTITUTE. RON CRAIG, CENE MULDOWNNEY, and PATRICK KELLY.

Blood on T-shirt and pants--small spots

-blue jeans

-on front of pants and shirt

-back behind John's house--did not see any on Gary

-same day

-threw in brown bag by the creek

-threw clothes right away

Smelled smoke when got into car--gun in glove box

like firecrackers--not a cigarette

Up and down the streets three or four times.

In front of the house not in the driveway.

They came out and Joey was coming down the road.

They were in there a long time (house)--stated one-half hour

Joey drove real slow.

He wasn't worried.--still 5 in and 5 out.

Never heard gunshots and never said that to anyone.

They would tell Joey where to drop them off.

Gary and Tyrone would tell Joey how they wanted to get dropped off.

Might of said M.O.

Picked house by them telling Joey where to stop.

Never heard shots.

Never told anyone about hearing shots.--did make statement at carwash.

Butch in car, back seat behind Joey.

Pulled in to turn around.

Tyrone said didn't want no witnesses or nothing.

Tyrone said he killed a couple people.

-when he got into car

-older people

Tyrone said took money or something.

Didn't tell him how he killed them.

Tyrone said they were getting hostile.

Tyrone is violent.

Tyrone was bragging about shooting bullet in floor.

Previous robbery- Tyrone made old person get in closet.

Tyrone said to take off when he got into the car.

Drove around-they showed Joey where to drive.

Why that house-Ron asked.

-Liked to rob old people

-Might of been old person out in the yard -going into house, had hat on.

Saw few people when going up and down the road.

Don't know how they picked out the house.

They probably saw an old person in the yard.

Joey saw someone out of the yard. Doesn't remember what they were doing.

Someone that lived there going into house.

-was older man, dressed up.

-Noling is the one who seen him.

-They said go down road and drop us off when guy went in.

-Joe saw him.

-Looked like he had a hat on.--conductors hat.

-Gary saw him.

-Gary and Tyrone together on all their stuff.--do things together

Car shopping- They would put things in Joey's trunk.

Remembers old mans house.

No jacket on.

Daytime-afternoon-before dark.

When left house, still daylight.

Thinks it rained the day before.

Cloudy day of the murder.

Wasn't hot, wasn't freezing.

They go into the house.  
They said drive up and down about three times real slow.  
Not really worried about seeing these people on the road.  
They were saying they were going to steal things.

Tyrone had little gun.  
Gary had sawed off shotgun.  
Carry gun to house by having them in their coat.  
Tyrone had long coat, but not that day.  
Gary-no long coat.  
Gary had pistol.--Gary had shotgun.  
Tyrone had automatic.  
Gary has sawed off shotgun.  
Tyrone's gun had a clip. About 4 inches (Joey showed us w/ hands.)  
Gary's was a revolver.  
Chico got all guns.  
Joey and Tyrone sold them all to Chico.  
~~Glovebox gun went to Chico.~~  
~~Other ones went a couple days before.~~  
Joey gave Chico glovebox gun  
-Met at Chico's house and got \$25.00 for it.  
Couple of days later, Joey went to dad's house.

Go into house for about one-half hour.  
Didn't hear yelling or screaming.  
Joey and Butch listening to radio, not worried.  
Wondering what took them so long.  
Usually were in (rob) real quick.  
"5 in and 5 out".  
Wondering what they were doing.

Didn't see them come out of the house.  
Running out front yard is when Joey saw them.  
Running towards 224.

WHILE IN THE CAR:

Tyrone in the front seat.

~~Tyrone threw gun in glovebox.~~

Gary looked upset and asked you do that.

Tyrone said shut up, he was screaming.

~~Smelled gun powder.~~

Tyrone didn't drop it.

Use to put in armrest.

~~Tyrone could of touched it and it was hot.~~

Gary is very pissed.

Gary kept asking why do that

Tyrone said shut up before he has to kill him (Gary).

Joey asked Tyrone why so long.

~~Tyrone said he had to kill a couple people b/c they were hostile.~~

Don't know how many shots.

Don't know the number of bullets.

Usually had lots of bullets.

Load gun and Johnny's house.--Butch says loaded gun in car.

Didn't watch him load at John's house.

Might of loaded it in car but usually at John's house.--was driving

In car, go right to Johnny's

-Stayed a couple of hours.

-Thinks Joey went back to mom's house.

-Joey then came back.

~~-Joey wasn't sure if they really did that (murder).~~

-Didn't call cops.

-Was worried about the old people.

-Joey figured they did something, but didn't really believe them.

-Joey was scared.

Back to Alliance

-They jumped out of the car and into the house.

-Thinks Tyrone left gun in the glovebox.

-Had more guns in house, sometimes in couch.

-Johnny not there much.

In house:

-Tyrone changed clothes, (Joey thinks in bathroom).

-Tyrone pissed off about blood.

-Little spots of blood on shirt and pants.

Tyrone said he killed a couple of old people.

Tyrone changed into jeans again.

Don't remember if Gary changed clothes.

Brown bag, grocery bag for the clothes.

Don't know of shoes and underwear.

Know it was pants and shirt for sure.

Tyrone dumped it at creek.

Tyrone told Joey he had to take them back behind house.

Tyrone and Gary arguing at Johnny's house.

Joey knew he did something (Ty).

Tyrone threatened to kill all if told.

No one was tied up.

All 4 at Johnny's house.

Couple days later picked up.

After murders, still car shopping.

Tyrone didn't say which one got hostile.

Never asked in which room murder happened.

When shooting starts, Joey doesn't know where Gary is.

They are usually together when doing robberies.

Doesn't know how many shots.

Probably lots b/c smelled gun powder.

Tyrone called Joey step-brother.

Tyrone called Joey about getting rid of the gun.

Guns probably gone if Chico has them.

Saturday nite, lots of girls came over, Joey doesn't know date.

After murder, there was a party but not positive which nite.

- Joey stayed at Johnny's.
- Thinks girls stayed.
- Worried about cops.
- Curtains closed every day.

First time after murder, when Ty. saw cops he hid.

Tyrone was scared.

Tyrone said to keep the curtains closed, doors locked.

Tyrone said keep mouth shut.

Tyrone said you tell anyone, I'll kill you.

- Joey believe him.
- It bothered Joey a little.

Tyrone sees cops outside.

While in house, they watched MTV and played video games.  
Didn't watch news or read newspaper.

Tyrone used Johnny's dad credit card before the murder.

Start cleaning up the house.

Put junk in trashcan, maybe in garage.

Seeing cops going up and down the street.

Tyrone would look out every 15 minutes.

Monday morning of arrest.

- Tyrone upstairs.
- Was gonna go out the window but saw cops.--outside.
- Tyrone went into closet.
- Before cops in house, Tyrone said don't say anything abt.  
murder.

-Tyrone wasn't worried about robberies.

-Tyrone kept saying keep mouth shut.

Joey got questioned.

-Conway wanted guns back.

-Tyrone there telling Joey not to get them back.

-Let Joey go.

Out of jail.

-Sold one gun to Chico.

-Got out maybe in morning.

Joey back to moms house.

Washed car and cleaned it out.

Threw out black bag in trash can. (Thinks it was Tyrone).

Thinks it was same day sold it to Chico.

~~Joey doesn't remember telling Ron about taking gun to basement, but~~  
now he doesn't remember--Thinks he could of said that.

Thinks he told Keith Koons.

Doesn't know about telling anyone else.

Happened at car wash.

They were pissed off b/c of robbery.

Joey said a couple things to the Koons.

Told them he drove them to Atwater.

-Little white house.

-Killed two people.

Occurred few days after murder.

Not sure which day it was.

Thinks same day he cleaned car.

Transcription of Tape; Present: Gene Muldowney, Ron Craig, Patrick Kelly and Joseph Delasandro.

JD: .....I'll pound the doors off the hinges. Six years aint nothin. A six year inaudible bin aint nothin, boy. Shit, take me on back jack. Six years inaudible, fuck this shit. Get this over with. Time fly by this three and one-half years. Then I aint gotta come back. ~~Gonna get me a lawyer.~~  
~~Gonna get me a good lawyer now.~~ I'm gettin Noling's attorney's number.

GM: Joe you're not, Joe you're not going to cooperate? Is that what you are tellin me?

JD: I tried to cooperate. I aint got no lawyer here, man. You guys are dickin me, ~~where's my lawyer?~~ FUCK, FUCK,

GM: Sit down. Sit down. Settle down. Alright. Alright. We were here ~~yesterday~~ with your attorney and we had a lengthy .....

JD: See, I can get this all over with when I go back to prison....

GM: Let me finish, let me finish, let me finish. We had a lengthy discussion and it was agreed that you would come in here today and you would give us a statement.....

JD: .....then I aint gotta come back to this place. cops bringing me here in cuffs and everything, inaudible.

GM: You agreed to that. ~~You shook my hand yesterday.~~

JD: ~~I aint got a good attorney.~~ ~~I aint got a good attorney to be doin nothin.~~

GM: You've already pled guilty.

JD: Then help me.

GM: You've already pled guilty.

JD: I know I pled guilty, and it's over, you're right and I'm gonna do six more years, and I'm maxed out, no parole, no nothin.

GM: You don't want to testify?

JD: Them years go just like that.

GM: Alright. Are you gonna testify or not?

JD: I didn't say I wasn't. I need a good lawyer here.

GM: Are you gonna give us a statement?

JD: I need a good lawyer here.

GM: Are you going to give us a statement right now?

JD: Not without a lawyer.

GM: Alright. Go ahead and take him out of here.
